7. Narrative Description

This is a one-story, three-bay, ranch house. The house sits on a concrete block foundation. The walls are frame, clad in aluminum siding. The side gable roof is clad in asphalt shingles.

The front (north) elevation has a single door entry slightly off center to the left. There are four wood steps up to a wood platform in front of the entry. The storm door appears to be aluminum. The wood door looks to be original to the house with three horizontal windows stair stepping down from the top. To the left there is one-over-one-light double-hung window. To the right of the entry is a picture window with flanking one-over-one-light double-hung windows. There is an aluminum awning over the picture window on this elevation.

The west elevation has paired one-over-one-light double-hung windows with an aluminum awning and a vent centered in the gable. Three concrete steps lead up to a concrete pad with metal railings in front of the single door entry.

The east elevation has two one-over-one-light double-hung windows. There is a vent centered in the peak. Due to a west to east slope in the lot, this east elevation has an exposed foundation. This foundation has a fake brick façade and a garage beneath the house. The non-historic garage door faces the east out to a driveway. There are two small one-over-one light double hung windows to the north of the garage door.

Also due to a north to south slope in the lot, the rear (south) elevation has an exposed foundation with three one-over-one-light double-hung windows in it. The first story has two sets of paired one-over-one-light double-hung windows and two separate one-over-one-light double-hung windows as well.

The garage would have been built at the same time as the house due to its location.

8. Narrative Statement of Significance

The Scannell-Jacobs House does not appear to be individually eligible for the National Register of Historic Places under Criteria A, B, or C. However, it does appear to be a contributing building in a potential West Hill historic district.

The Scannell-Jacobs House is a typical example of a ranch style house with a hip roof. However, it does not appear to have any particular architectural significance. Additionally, it does not appear to be associated with any significant events or people. Thus, the Scannell-Jacobs House does not appear to be individually eligible for the National Register of Historic Places under Criteria A, B, or C.

However, the Scannell-Jacobs House does appear to be a contributing building in a potential "West Hill" neighborhood historic district. It reflects the neighborhood development in the mid 1950's. It has very definitive characteristics of a typical ranch house built around this period and still retains the integrity of this style.

Mark and Catherine Scannell built two houses on Lot 6 in 1954, apparently with the intent of selling both. A building permit was issued to Mark Scannell for \$12,500 to construct new home at 300 W. 3rd Street on August 26, 1954 ("Building Permits," *Muscatine Journal*, December 30, 1954, sec. 4, p. 8). On the same day, a permit was also issued to Scannell to build a house at 210 (212) Pine for \$12,500. They sold all of Lot 6 to LaMoyne and Doris Jacobs on January 10, 1955 (Deed Book 154: page 492). The 1956 city directory shows the first listing for this address; LaMoyne and Doris Jacobs are listed as the residents and owners. LaMoyne is indicated to be working as a clerk for City Water and Electric. The Jacobs continue to be listed as the residents here at this address through 1962, with the only change being to LaMoyne's occupation, which in 1958 indicates he is the superintendent of Greenwood Cemetery.
